**SPRINGFIELD USBC WOMEN'S BOWLING ASSOCIATION
RULES FOR 2010-2011 CHAMPIONSHIP TOURNAMENT
AMF LAKETOWN, SPRINGFIELD, ILLINOIS**

This tournament is certified by the United States Bowling Congress and as such is governed strictly by the rules of that organization.

1. An entrant must be a female member of the Springfield USBC Women's Bowling Association.
2. An entrant may participate in ANY team event **THREE** times; **HOWEVER**, not more than three players on a 5-woman team can place more than once in the prize list for position standings. On a 3-woman team, all members must be different to cash. Makeup teams are allowed. Substitutes and members bowling in mixed, trio, doubles, and singles leagues are eligible. Entrants may participate only one time in the doubles and singles events.
3. Six (6) bowlers to a pair of lanes in doubles and singles events, if possible.
4. **TARDY PLAYERS:** Bowling shall begin in accordance with the previously arranged schedule. Any player or team arriving late shall begin play and the score shall count beginning with the frame then being bowled. If an entrant is late for the doubles event, the entrant present shall bowl her singles first. If her partner has not arrived by the time the singles event is finished and a substitute cannot be found, the entrant present shall be permitted to bowl her games in the doubles in order to qualify her for the all-event championship.
5. The **CHAMPIONS** in the 5-woman team, 3-woman team, doubles, singles, all-events and senior events, based on actual scratch scores will be named **LOCAL CHAMPIONS** and they will receive individual awards. **HANDICAP WINNERS** will receive individual awards along with money for first place. Both **SCRATCH** and **HANDICAP WINNERS** receive magnets. **SPONSOR TROPHIES** will also be awarded in 5-woman and 3-woman team events to those team with a paid sponsor.
6. Handicap will be based on 90% of the difference between the highest league average (regular or substitute) and 220 scratch as of the end of the 2009-2010 winter season. Entrants shall use their highest average in a Springfield USBC WBA league as of the end of the previous winter season schedule for at least 21 games. If an entrant has no previous season average, the highest Springfield USBC WBA summer league average for at least 21 games of the previous summer league schedule shall be used. An entrant not meeting one of the above requirements shall be permitted to bowl in the tournament, using her highest current average in a Springfield USBC WBA league for at least 12 games as of their date of participation. All others shall bowl scratch. Rule 319a will not be used nor does a bowler need to report their previous winnings.
7. ****ALL EVENT SCORES WILL ONLY BE CONSIDERED IF AN ENTRANT PAYS THE \$2.00 PRIZE FEE. The all events prize fee MAY BE PAID ONLY BY THOSE ENTERED IN ALL THREE EVENTS – 5-WOMAN TEAM, DOUBLES AND SINGLES.** Paid all events are not transferable unless the substitute replaces original entrant in all three events and the transfer is made by the tournament manager or her assistants prior to the time of the substitute's participation in any event. If the entrant is bowling more than **ONCE**, the **FIRST 5-WOMAN TEAM SCORE BOWLED**, shall be used for her **ALL-EVENT** score.
8. ****All senior optional event scores will be considered if the entrant pays the \$2.00 fee. The senior optional event fee may only be paid by those 65 or older as of their date of participation. The 3-game series scores from any team event bowled (5 or 3-woman) will be used for this optional event. If the entrant is bowling more than once, the first team score bowled shall be used for her senior optional event score.**
9. The prize Fee will be \$7.95 per person per event for Team, Doubles and Singles and the Tournament Expense will be \$7.50 for lineage (3 games) and \$1.55 expenses or \$17.00 per person per event. \$2.00 all event fee (optional). Senior Event participation fee \$2.00 (optional).
10. **ALL FEES OF \$17.00 PER PERSON PER EVENT MUST ACCOMPANY YOUR ENTRY BLANK INCLUDING ADDITIONAL \$2.00 FOR OPTIONAL EVENTS. MAKE ALL CHECKS OR MONEY ORDERS PAYABLE TO " SPRINGFIELD USBC WBA." PERSONAL CHECKS WILL BE ACCEPTED WITH A \$25.00 CHARGE FOR ALL RETURNED CHECKS.**
11. Prizes will be paid to one-third of entries in team, one-fifth of entries in doubles and singles events. Prizes for all events will be paid on the basis of one out of every fifteen entries. One hundred percent (100%) of prize fees shall revert to prize fund.
12. Captains and individual entrants **MUST REPORT** to the tournament manager or her assistants **AT LEAST THIRTY (30) MINUTES BEFORE** they are scheduled to bowl and **AT LEAST ONE (1) HOUR BEFORE, IF A SUBSTITUTION IS TO BE MADE.**
13. The Springfield USBC WBA Board of Directors reserves the right to make any rule or issue any formal opinion not covered by the rules and regulations of USBC, Inc.
